# Section 6 — Legislation, Provincial Policy, and Status

Laws are in place to protect Ontario's wildlife and the habitat that sustains them. The outcome for wildlife protection depends on our understanding of and compliance with the laws in place. The various Acts serve many conservation purposes.

## SNAKE PROTECTION AND ONTARIO LAW

## COSEWIC, RENEW, AND COSSARO

In Canada, federal and provincial government agencies and non-governmental organizations co-ordinate wildlife species conservation through the Canadian Endangered Species Conservation Council (CESCC), and the committee for the REcovery of Nationally Endangered Wildlife (RENEW). The Committee on the Status of Endangered Wildlife in Canada (COSEWIC) designates species at risk and RENEW oversees recovery activities. COSEWIC evaluates and designates species as not at risk, special concern, threatened, endangered, extirpated or extinct. Provincially, the Committee on the Status of Species at Risk in Ontario (COSSARO) also uses criteria to designate a species into an at risk category.

## COSEWIC Species Risk Categories

#### **EXTINCT**

A species that no longer exists.

#### **EXTIRPATED**

A species that no longer exists in the wild in Canada, but occurring elsewhere.

#### **ENDANGERED**

A species facing imminent extirpation or extinction.

#### **THREATENED**

A species that is likely to become endangered if limiting factors are not reversed.

#### **SPECIAL CONCERN**

A species is of special concern because of characteristics that make it particularly sensitive to human activities or natural events.





- Originally, the eastern massasauga rattlesnake was given legal protection through the Ontario Game and Fish Act in May of 1990. In 1997, this act was replaced by the Fish and Wildlife Conservation Act.
- In April, 1991 the Committee on the Status of Endangered Wildlife In Canada (COSEWIC) designated the eastern massasauga rattlesnake as threatened in Canada.
- The Ontario Ministry of Natural Resources designated the massasauga as threatened in Ontario in 1998, through recommendations made by the Committee On the Status of Species At Risk in Ontario (COSSARO).

### THE FISH AND WILDLIFE CONSERVATION ACT (1997)

The purpose of this Act is to preserve at-risk wildlife. It covers the mammals, birds, fish, amphibians, and reptiles native to Ontario. The Act lists the eastern massasauga rattlesnake as a "specially protected reptile." This designation legally protects the massasauga from being harassed, captured, killed, bought, or sold. A violation of the Act can result in a maximum fine of \$25,000 and/or imprisonment for up to a year. A violation for commercial purposes increases the penalty to a maximum fine of \$100,000 and/or imprisonment for up to two years.

## THE PLANNING ACT AND PROVINCIAL POLICY STATEMENT


The Provincial Planning Act governs municipalities in the development of private lands. Natural heritage features are addressed in the Provincial Policy Statement (PPS) of the Planning Act. The habitats of threatened and endangered species are considered natural heritage features. In order to proceed, official plans and by-laws must account for the PPS requirements and other planning documents. The Act states that development and site alteration will not be permitted in

significant portions of the habitat of endangered and threatened species, but may be permitted on adjacent lands if the proponent has demonstrated that the development will have no negative impacts on the at-risk species in that area.

#### **TECHNICAL GUIDELINES**

The Eastern Massasauga Rattlesnake Recovery Team is producing a document that provides technical guidelines in identifying eastern massasauga rattlesnake habitat. The team hopes the guidelines will help people determine whether significant portions of snake habitat exist in an area being considered for development. Ideally, the document will promote sound planning and management in these areas.

The guidelines represent the most up-to-date resource management information available, and are intended for use by ecologists, biologists, planners and others involved in the identification of the significant portions of the habitat of this species. It will also aid the recovery of the species by focussing efforts on the most important locations.
